**Assumption of the Risk and Waiver of Liability Relating to  
Coronavirus/COVID-19**

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Alce Art Studio Inc. (dba.) **Heroes of Hip Hop** ("HHH") has put in place preventative measures to reduce the spread of COVID-19; however, HHH cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending HHH could increase your risk and your child(ren)'s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending HHH and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at HHH may result from the actions, omissions, or negligence of myself and others, including, but not limited to, HHH employees, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at HHH or participation in HHH programming ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless HHH, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of HHH, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any HHH program.

## hhh Covid-19 Guidelines

The health and safety of our dancers and staff is of the utmost importance to ALCE Art Studio Inc. & Heroes of Hip Hop. We continue to monitor the COVID-19 situation and the recommendations of not only the Centers for Disease Control (CDC) but also the State of Florida Department of Children and Families and how those recommendations impact similar programs. As the current situation is fluid and constantly changing, we will continue to update this document as changes occur.

### Capacity and Group sizes:

Although the CDC and state government have not placed a limitation on capacity for summer camps, HHH has decided to limit the capacity for the 2020 Summer Camp School Of Rock. Our Camp usually works on a 50% capacity, but this year we will be reducing the capacity to 30%, which is approximately 30-35 kids and 5 staff members. A smaller group size will help with social distancing during all activities.

### Safety and Sanitation:

HHH, staff, parents and dancers all play an important role in ensuring that our camp is safe. HHH will review and implement the CDC guidelines as well as the local health department recommendations. **We need your help by NOT sending your children if they are sick** and let them know ahead of time, that HHH will be taking plenty of breaks during the day to ensure that everyone wash their hands, and to sanitize the dance, eating, craft items and game areas.

### Masks or Gloves:

Campers are encouraged to wear a mask for most of the day, but it is not mandatory. This is up to the parents' discretion. We understand that face coverings may be challenging for some campers (especially the younger campers) to wear in all-day settings such as camp and exercising.

Staff members are required, however, to wear their mask during camp and regular classes.

Gloves are not required for dancers. Staff will wear gloves during pizza distribution on Fridays.

### Screening and Monitoring:

All Staff and Campers will be screened for symptoms during drop off. Temperature will be checked at arrival. Hand sanitizer will be provided at arrival and dismissal. All staff and campers will have access to hand sanitizers during the day if needed.

Help us prevent illness:

In addition to implementing the screening for fevers HHH staff will:

1. Promote healthy hygiene practices such as hand washing and covering coughs and sneezes;
2. Intensify cleaning, disinfection and ventilation; and
3. Implementing social distancing practices such as limiting spots in camp, classes and activities. Floors are marked for dancers to know where to stand and keep their distance from their peers.

We are excited to start our camp and classes and look forward to dancing together again as a team!!
